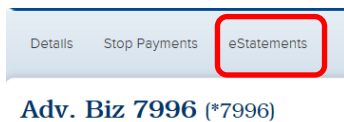




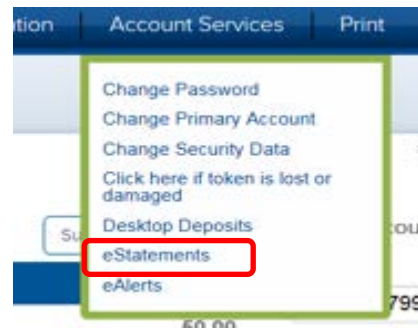
## eStatements

The System Administrator will need to enroll in eStatements in order for the remaining users to be able to access eStatements. eStatements can be accessed from the Account Information page or from the Account Services tab.

## Enrolling in eStatements

1. Click on eStatements from the Account Information page or the Account Services Tab
2. A separate eStatements enrollment tab with the Disclosure Agreement will open up. It contains the Terms & Conditions for eStatements. Read the Terms & Conditions then click on the blue [eSign document](#) link to get your eSign confirmation Code.
